Our production is scheduled to film in your areas. Please see detailed information about the shoot listed below:

- **Where:** Filming will take place at 500 Gold Ave SW.
- **When:** Filming will take place on 06/11/2018 at 5:00am through 06/11/2018 at 9:00pm.
- **Night filming:** This episode will film on 06/11/2018 at 5:00am till 06/11/2018 9:00pm. If production lights or sound are of concern please contact anyone listed below.
- **Work trucks** will be parked on the north side of Gold Ave between 5th and 6th street, as well as on the north side of Silver Ave between 5th and 6th street.
- **Basecamp:** Basecamp will be located at the Rail Yard, 1100 2nd St NW.
- **Parking:** No parking signs will be in place on the north side of Silver Ave between 5<sup>th</sup> and 6<sup>th</sup> St. No Parking will be enforced in this area during our prep (June 7 & 8, 8a – 8p), filming (June 11, 5a – 9p) and wrap (June 12, 8a – 8p). No Parking signs will also be in place on the north side of Gold between 5<sup>th</sup> and 6<sup>th</sup> St. No Parking will be enforced in this area during filming (June 11, 5a – 9p). Vehicles still parked in this area by 3am on June 11 will be towed.
- **Street closure:** The alley between Silver and Gold Ave/ 5<sup>th</sup> and 6<sup>th</sup> St will be closed on June 11, 2018 from 5:00am – 9:00pm.
- **Intermittent Traffic Control (ITC):** (Intermittent Traffic Control) There will be no traffic control for this location. However, an APD officer will help crews safely cross Gold Ave. During filming residents/businesses will have complete access to their property but may experience brief delays.
